- All juniors must be accompanied by an adult at all times. Properly fitting hard riding hats, body protectors, to current British standards, and footwear with heels must be worn at all times whilst mounted.
- Any fences that are damaged or seen to be damaged, must be reported to the office/house.
- Large map on the office wall must be read before entering the cross country course.
- Fences **must** be jumped the way they are flagged, keeping the red flag on the right and the white flag on the left. **DO NOT** jump fences that are not flagged.
- **All accidents must be reported and an accident report completed at the office/house.**
